# LIBERTY, EQUALITY, FRATERNITY

Verbal engineering uses
Words as Weapons for social engineering

THE FRENCH REVOLUTION of 1789 adopted LIBERTY EQUALITY, FRATERNITY from *Due contrat social*, "The Social Contract, by Jean Jacque Rousseau, 1762.

It sounded so true, so noble and so good -- but became a pretext for Liberty to negate Equality by murder; for State enforced Equality to negate Liberty; and for the guillotine to discriminate against Fraternity.

Similarly, today's academics claimed freedom from censorship. They claim it for themselves but deny it to Western Civilization and Christendom. Their students, so intellectually and emotionally fragile, need 'trigger warnings' and 'safe spaces'.

## DISCRIMINATION DIVERSITY DIFFERENCE

This Bill uses words as weapons. Discrimination against some specified diversities and differences is illegal. But for those changing gender, it will be legal to discriminate against the diversity and difference of Christianity. This negates far more fundamental freedoms such as conscience, religion, freedom to think contrary thoughts, to speak out, to publish.

Is it not a lateral leap lacking logic to equate the misfortune of intersex in those rare cases of muddled chromosomes and genitalia, with the entirely different problem of hapless youths who seemingly missed out on an upbringing in a stable marriage blessed with siblings and friends, of growing up with those of their own sex and the opposite sex, and who later suffered from politically motivated propaganda at school to change their sex or gender?

What evidence is there for discrimination in religious schools? Have there been expulsions or bullying in religious schools? If such exist, are changes in the law really necessary to fix it?

What need is there for this Bill when staff or students who repudiate Christian sexual morality have no need to be in Christian schools at all? How can they claim a right to set its agenda?

Christian parents have a natural right to raise their children and to choice of schools. Like all tax-paying parents, they choose schooling to suit their beliefs and values. Would the Labor Party be expected to employ supporters of the Liberal Party? Will the imposition of alien moralities be tolerated in Islamic schools -- or erupt in violence?

### A NEW RELIGION of ANTI-RELIGION

Will this Bill weaken the autonomy of religious organizations? Or attack their freedom to exist?

Does this violate our Federal Constitution and indeed the more general principle of separation of Church and State taught by Jesus Christ:-

Render therefore to Caesar the things that are Caesar's, and to God the things that are God's.

Matthew 22:21

Is the ENLIGHTENMENT to be replaced by an en-darken-ment to become the EN-NIGHTEN-MENT?

Will this Bill empower the Australian government to establish a religion of its own, a State religion to replace traditional religions?

Is the State establishing a religion of anti-religion, with its own creed, ethics and forced conversions, all enforced by law – ctually an anti-religion of atheism, amorality and immorality, a religion whose Almighty is the State and whatever it dictates?

#### ATHEISM, Science and Conscience

Atheism is against modern science. Atheism assumes there is no God, and thereby rejects the basic philosophy of science to work from evidence and reason and its unstated philosophical assumptions that reality and our minds are rational and capable of knowing truth.

For instance, the SEARCH for EXTRA-TERRESTIAL INTELLIGENCE (SETI) assumes we shall recognize order and design in radio signals, and take them as the **signature** of intelligence and purpose. If this applies to outer space, it is scientific to assume it applies on earth, where scientists daily discover new wonders in our world and bodies, the signature of an unseen Super Intelligence and Power, Almighty God.

The Creed of atheism rejects conscience and objective morality. Harmony among citizens in an atheist society has to be imposed by *external force*. Without conscience, there is no internal restraint. Without religion, only a subjective morality remains. It is far more expensive to run the country in this way, and to depend on the fear of the police, increasing surveillance and increasingly costly welfare.

This is dictatorship, not democracy.

# **MULTICULTURALISM and EQUALITY**

ULTICULTURALISM was a new political deception to brainwash us into false ideas of equality. It replaced assimilation and integration.

The media and the school systems promoted it. Its absurdity became obvious, even to the gullible, in the suicide murder of 3,000 innocents in the destruction of the Twin Towers in New York, in 2001. Natural morality sustains harmonious living. Harmonious living depends on shared values.

Shared values depends on the culture.

The culture depends on a religion.

Therefore **natural morality** sustains (and is sustained by) religion, and no religion can negate it.

#### THE TEN COMMANDMENTS

(called the Ten Words in Jerusalem Bible, Exodus 34:28)

Natural morality can be known authentically from human reason and experience. For His Chosen People, however, God revealed basic morality to Moses (Exodus 20:1-17, Deut.5:6-21), since His Chosen People were so 'stiff- necked' (Exodus 34:9) and otherwise might fail to know and observe it.

Earlier, about 1760 B.C. in Babylon, The Code of Hammurabi legislated for a harmony in society (see <a href="https://www.wildsidebooks.com">www.wildsidebooks.com</a> for Wildside Press, LLC, 2009) with six of the Ten Commandments: not taking God's name in vain (2 0; honouring parents (4); no murder 95); no adultery (6 0; no stealing (7); no false witness (8).

This natural morality was scattered throughout Hammurabi's Code, but it lacked the logical sequence of Moses -- cf. *Catholic Family Catechism Apostles Edition* nn. 371-372, *Disciples' Edition* p. 93. Even without revelation, this natural morality was the foundation for detailed laws.

#### **Political Correctness**

Student mobs shout down, harass and intimidate any who challenge the current political correctness and its

slavish anti-intellectual conformity.

Who decided that 'equality should be Politically Correct?
